

**Honourary Life Associate**

Awarded to individuals in recognition of their years of hard work and dedication to promote and advance the ideas of arboriculture and urban forestry within Ontario.

Note: Under the new Canada Not-for-profit Act and the current ISAO By-law, we cannot have more than one class of membership. Therefore, we have Honourary Life “Associate” which is the equivalent award in intent as the previous Honourary Life “Membership.” This change in wording was approved at an Annual Meeting of Members and is recorded in the ISAO Policies and Procedures

Note: This award can only be awarded once to any individual.

## Criteria

### 1. Years of Hard Work and Dedication

By “years” is meant at least 25 years. This is the highest ISAO award possible and requires an extraordinary contribution over an almost entire or entire career.

Provide a listing of this person’s years of hard work and dedication to promote and advance the ideas of arboriculture and urban forestry within Ontario over at least the past 25 years, providing specific dates.

### 2. Hard Work

By “hard work” is meant that an extraordinary degree of effort was expended and that considerable challenges were overcome through these efforts.

Describe this person’s efforts over the past 25 years to promote and advance the ideas of arboriculture and urban forestry within Ontario. This description must demonstrate that the efforts constituted “hard work.”

### 3. Dedication

By “dedication” is meant persistence and loyalty towards a given purpose. The purpose is to “advance the ideas of arboriculture and urban forestry within Ontario.”

Describe the person’s persistence towards the purpose of advancing the ideas of arboriculture and urban forestry within Ontario over at least the past 25 years. This must be a detailed listing (including time notations) of their activities and achievements.

### 4. Promote the ideas of arboriculture and urban forestry in Ontario

By “promote” is meant “to further the growth, development, establishment, progress or public knowledge and opinion of.”

Describe this person’s activities “to further the growth, development, establishment, progress or public knowledge and opinion of the ideas of” arboriculture and urban forestry in Ontario.

This should include a listing and description on this person’s achievements – on how they “promoted” the ideas of arboriculture and urban forestry in Ontario and what their achievements were. It is noted that the influence of promotion is hard to measure; and therefore, an emphasis on the promotional activities themselves is considered acceptable.

5. Advance the ideas of arboriculture and urban forestry within Ontario

By “advance” is meant “to move forward” and “to progress.” In other words, “advancing the ideas of arboriculture and urban forestry” would involve developing and/or encouraging the adoption of ideas and practices that improved the practice of arboriculture and urban forestry.

Provide a listing and description on this person’s achievements – on how they “advanced” the ideas of arboriculture and urban forestry in Ontario and what their achievements were. A listing of others who could validate/confirm these achievements should be provided if possible.

Endorsements by others may and should be submitted as additional evidence of the worthiness of the nominee. A diversity of endorsements, including but not limited to community contacts (residents, businesses, elected officials) and that of accepted experts (public and educational institution representatives, landscape architects; arborists, environmental experts, etc.) will strengthen applications.

Note: This is the highest award available from the ISAO and is intended as a “lifetime achievement” award. It is not automatically awarded annually; rather, nominees must meet the very high standard required to receive it. Typically, only a member of ISAO will qualify for this award although this is not a strict criterion; a nomination for a non-ISAO member will be considered based upon the merits of the nomination.
